He said, when a new customer would ask him for a bid and accept it, he would always charge less than what he quoted. After that, the customer would never ask for a bid again.

I asked him how he would handle customers who owed him money. He said he trusted everyone at first, and if a customer cheated him once, shame on that customer. If a customer cheated him twice, shame on him.

He told me that it was good to feel tired at the end of the work day, as it showed you gave it your all. And he said, if you worked hard, you deserved a beer at the end of the day — but only one beer.

Following in a parent's footsteps with a career choice isn't an easy task for those who accept the challenge, as there will clearly be differences of opinion on how to do things "the right way." There will also be many examples of continuing procedures or having policies in the

same way mom or dad did. We share a handful of local examples of these in this month's cover story.

Meanwhile, in one way or another, most all of us are continuing the traditions and lessons our parents shared with us by taking those same steps. And, as we are discovering, those can be big shoes to fill.

IN THE FAMILY'S FOOTSTEPS

Family professions, businesses pass on to the next generation

Family roots run deep in Panora. Because of this, many local families have seen younger generations follow in the family business or line of work. Here are a few of their stories.

ROD AND THAD STANLEY

In Panora, students have been interacting with Mr. Stanley for a long time, because there have been two Mr. Stanleys, and they happen to be a father and son pair.

Rod is the elder Stanley, and he told of the various stops in his career as an educator.

"I graduated high school in 1968," he said. "Then I went to Tarkio College in northwest Missouri from 1968 until December of 1971. I played football there for four seasons. Then, my first teaching job was at Dexfield. I spent a year and a half there, and then I went to eastern Iowa at a school district called HLV (Hartwick-Ladora-Victor) and I was there 1973 to 1979. And I did coaching at both schools. Then I moved to Bondurant, 1979 to 1989."

During these years, Rod and his wife were raising a family that included six children.

"In 1989, we moved to Panorama," Rod said. "I coached and taught mostly middle school history, sixth grade. Overall, I spent 35 years teaching and retired in 2006."

Looking back over his teaching career, Rod said he followed a simple philosophy.

"To get respect, you've got to give it," he said.

Rod talked about the traditional foundation of education being the "Three R's" of Reading, (W)Riting, and (A)Rithmetic, but he and his son agree that there should be a fourth R — Respect. That's the mindset the Stanleys have used in their years as educators.

Rod added that he often speaks with former students, and he finds that re-warding.

"I don't regret my career choice. I taught at a great time," Rod said. "And when Thad went into education, I was happy that he did."

Thad described his own education and the various stops in his teaching career.

"I graduated from high school here in 1996, then went to Central College, graduating in 2000," Thad said. "Then I taught at Oskaloosa from 2000-2006, working with the at-risk group."

Thad's career path has included mostly small schools, with one notable exception.

"I got engaged and moved to Kansas City, where there were 26,000 students in the district. Then we moved to Grand Island, Nebraska," said Thad. "That's where I taught general education for the first time. Then I decided to get a master's degree. And I got really lucky when Panorama was looking for an assistant principal. That was in 2014/2015."

Thad now serves as the principal for grades 6-12 at Panorama and believes in finding "teachable moments" throughout his dealings with students.

"To me, you hope that you make a difference. And you hope they remember you for being respectful," said Thad. "If you ask any kid out here what they want, it's always 'respect,' every time. That hasn't ever changed."

Thad keeps a realistic attitude and enjoys the humor and variety his job entails.

"We're dealing with 400 teenagers in

one building," Thad said. "What else can happen?"

TOM AND TROY REINHART

Troy Reinhart grew up with three family members working in the grocery industry. Troy's father, Tom, along with Troy's uncles, Don and Dave, worked in management of local grocery stores.

"They opened the store in Guthrie Center about 1975, and then they built the store at the current location approximately 1989," said Troy. "Then they purchased the stores in Panora and Stuart in

1994 and 1995."

All three stores are known today as Hometown Foods. Tom, Don and Dave made the grocery business their career, until they were ready to consider retirement. Then it was time to look for someone to take over the businesses. Luckily, Troy was ready to step in as the next generation of store owner/manager.

"It's been nearly 30 years. They did the grocery store thing for a long time," Troy said. "January of 2023 was when I purchased the three stores. My dad is mostly retired, but he still helps out a little bit. Don just recently passed, and Dave is fully retired."

Troy explained that, although he worked in the stores as a teenager, he had considered other career paths.


"In high school, I wasn't sure if I wanted to do it or not," Troy said. "I was in Des Moines for a while. Then I worked for Hy-Vee for four years. Now I've been back here in Panora since 2004."

Owning and overseeing three stores keeps Troy busy.

"The majority of my time is here in the Panora store, but I'm in the other two stores, usually once or twice a week," Troy said.

Ron, Josh and Jack Eike have continued the family business.

Troy and his wife, Steph, have six children, and he says that, so far, none have decided to make a career in the grocery store field, although all have worked for him.

Troy pointed out that, over the years, much has changed in the grocery business.

"Obviously, technology has changed a lot in retail. It changed from everything being marked with a sticker and keyed in at the register to now everything digital and scanned," Troy said. "And, obviously, competition has changed. It used to be that every little town had a grocery store. Now it's a whole different world with the Wal-Marts and Costcos."

Troy pointed out that he strives to carry local products in his stores, when possible. Another focus is the customer.

"The most important thing is customer service," said Troy. "We want to be fast, friendly and close to home."

Being part of a family business has

meant a lot to Troy.

"I have good memories of my dad, uncles and cousins and me all working together," he said.

RON, JOSH AND JACK EIKE

In 2002, Ron Eike purchased 11 acres of land near Yale. His plan was to grow and sell trees as something to do in retirement. That modest tree farm has spawned two family-owned businesses and a new partnership. Ron and his wife, Shirley, purchased a home at Lake Panorama in 1999.

"We were looking for a vacation property where we could enjoy family vacations and also looking ahead to retirement," Eike says. "When we looked at Lake Panorama, we realized we had found Iowa's best-kept secret."

Soon after settling in their vacation home, the couple's oldest son, Josh, suggested Ron purchase some property and plant trees.

"I've always done my own landscaping, and Josh knew I love trees," Eike says. "And I was starting to think about what I'd do once I retired."

"We planted 2,000 trees that year," he says. "Each year, we cleared more land and added trees until we had planted 12,000 trees."

It took four years for the property to be fully planted with trees and for the first trees to be harvested and marketed. Customers throughout Iowa were buying from the Wood Duck Tree Farm. Soon there was customer demand for more than just trees, and, in 2015, Wood Duck Landscapes was formed. Now Josh Eike, who first suggested the idea of growing and selling trees, is the principal partner and functions as the CEO of Wood Duck Landscapes. When asked if Ron still is involved in the business, Josh laughs.

"Oh, yes, he's still around. He likes to keep tabs on what we're doing almost every day," he says.

The third generation in the Eike family business is Josh's son, Jack. As a teenager, he worked for his father and grandfather each summer. Now 23 years of age, he has his own business that works in tandem with Wood Duck Landscapes. In early 2021, Jack Eike's BluGrade Earthworks, Inc. was formed. The primary focus of BluGrade is grading, shorelines, large structural retaining walls, dirt work, trucking and hauling.

"He grew up in the business," Josh says. "He's been in a skid loader by himself since he was 6 years old."

Jack now lives in the house at the original tree farm and runs his business from there. He also is president of Wood Duck Landscapes. Late last year, the Eikes formed a partnership with Tyler and Aubrey Rupp, owners of Deluxe Docks and Lifts. This legal partnership now owns Deluxe Docks and Lifts Barge Service.

"Josh did some work at our home a few years ago, getting our shoreline in shape so we could install the dock and lift we wanted," Tyler Rupp says. "We've talked about a possible partnership the last couple of years and spent time researching how we could coordinate all the pieces customers want for their outdoor spaces."

Eike said he's proud that the companies have completed many successful projects throughout the area, and that the companies give back to support the needs of the community. But what is Eike's favorite part of his business?

"Taking someone's dream of a beautiful outdoor area from concept to finished product is really satisfying," he says. "Plus, I've made a lot of friends at the lake over the years. I've built a lot of patios where I've later been invited for beers."

Some things naturally seem to go together, such as hot dogs and baseball or summer and the beach. But what about a hair salon and a classic car? Although this might not seem like a natural match, Kellie Flanery of Panora explained why this pairing works well for her.

"I grew up out at the lake, and my husband is from in town," she said. "He and his brothers had a garage, and they were always hot-rodders. I never really liked cars all that well, but I started a hair salon and named it Retro LUX. Then I kind of started getting into doing pinup stuff, and it brought me a reason to like that old car stuff."

So she talked with her husband, Tom, about incorporating a classic car image into her salon's motif. After some asking around, Kellie and Tom found someone who owned a 1953 Chevy and who was willing to sell it.

Flanery recalled that the car was in fairly good shape.

"The body was all done, except it needed a paint job," she said. "It drove. It had the original motor, and it was a 'three on the tree.' So, we drove it home, and I picked out a nail color from my salon that I really liked and got it painted that color."

She recalled that the car didn't have power steering, and the engine smoked. But when Tom had extra time during the pandemic, he started fixing the various issues the car had. Kellie's brother-inlaw, Dan Flanery, also did some work on it, and Kellie is appreciative of the help in getting her car all fixed up.

"It's running perfect now," she said. The car has become the icon of her business, and its personalized license plate says "RETROLX." Flanery rattled off some of the other details about the car.

"It's a 1953 Chevy 210 two-door. It has a 355-cubic-inch small-block Chevy automatic transmission and posi-trac rear end," she said.

But, she added, the specific technical details are not her focus.

If you have not been to the movies lately, you've missed some good films. Some of these will still be in theaters, but others might be close to streaming. Keep this article handy to remind you to look for them.

"THE TEACHERS' LOUNGE"

I knew nothing about this movie going in and have praised it ever since that day. It is nominated for Best International Film (formerly known as Best Foreign Film). It is in German with subtitles. By the way, contrary to public opinion, no one has ever been injured by a subtitle. The movie is about a teacher in a German school who discovers a co-worker is responsible for thefts in the teachers' lounge. When she confronts her, you know what hits

the fan. And, of course, the person denies the accusation, and it becomes a "she said/she said" battle with the accuser being the one who is persecuted. It is a powerful film and a powerful statement on the world we live in. One of the best films I saw last year. **Grade: A**

I drove across Des Moines from the south-side Fleur Cinema to Waukee and The Palms Theatres to see the second movie of the day, a modern twist on the Frankenstein story. My expectations were low, but the film managed to surprise me. It was entertaining and,

A high school girl hanging out with a guy who literally pulled himself from his grave during a lightning storm is a unique story, but Diablo Cody, who wrote the great movie "Juno" back in 2007, shows that she still has the chops to write a funny and clever film. **Grade: C+**





"Madame Web"

"The Teachers' Lounge" was intense and powerful, but this look at the people living in an opulent home next to the notorious Auschwitz prison camp ranks close. It's an oddly made film, giving us scene after scene of their everyday life with little formal storytelling. It is a story that is difficult to believe. The screams and gunshots were completely ignored as if they didn't happen. Tough to sit through, but a fascinating tale. **Grade: A-**

"MADAME WEB"

Dakota Johnson from the "Shades of Grey" films joins the Marvel Universe as a fringe character in the Spider-Verse in an effort from the Sony company to continue to milk the Spider-Man deal they

signed years ago with Marvel Comics. The film has been universally trashed, and Johnson has been excoriated. My grown son and I went to this with low expectations, and we both enjoyed it. Not sure what people were expecting. **Grade: C+**

"BOB MARLEY: ONE LOVE"

My knowledge of Bob Marley is limited. I know a couple of his songs, but the depth of his political activism and his dogged artistic drive were surprising to me. The movie is well made, but I really could have used subtitles as the accents, though accurate, were difficult to understand. It is a good movie that I will rewatch at home with subtitles and will probably appreciate it even more. Grade: B+



"Drive-Away Dolls"

Director/writer Joel Coen (of the Coen brothers) gives us a raunchy and profane story of two women on a road-trip in a car with a unique present in the trunk. The movie and the language never hold back, which produces a mixture of shock and "laugh-out-loud" moments. One of the craziest movies I've seen in a while, and it is sure to offend many. **Grade: C**

"DUNE: PART 2"

One of the movies I was most looking forward to this year. Director Denis Villeneuve and a tremendous returning cast deliver a super-long (2:45) sequel that, in my opinion, brings up more questions than answers. I loved the first film, but this sequel was long and confusing. Word to the wise — if you are going to see

PAUL H. MILLER 1949-2024

Paul Homer Miller, 74. son of Homer and Cecelia (Dietrich) Miller, was born June 14, 1949, in Sigourney. He passed away Saturday, March 2, 2024, after a short battle with esophageal cancer.

Paul attended schools in rural Kansas and What Cheer. In 1966, Paul began working as a union traveling iron worker for the next 20 years. In 1988, he married Kathryn Brandt in Adel. They made their home in De Soto

for a short time before achieving one of his life's dreams by buying land worthy of hunting and fishing south of Panora, where they have been ever since. Paul then worked for Ironworkers Local 67, Des Moines on many notable projects, including 801 Grand in Des Moines and Iordan Creek Town Center in West Des Moines, commuting daily from Panora until his retirement in 2009.

Paul enjoyed outdoor recreation immensely including both bow and shotgun hunting for deer, turkey hunting, fishing in any form whether river, lake, pond, or ocean, camping and, in later years, gardening. Paul was always willing to share his knowledge of the outdoors with any family kids.

A primary philosophy of Paul's was to work smarter, not harder, and while he saw evidence of the opposite everywhere, he was always willing to teach and let people learn in their own way. A quiet giant to his family, he was well-versed in colorful language, had a vibrant personality and was set in

his ways. He would always help Kathy in her projects in any way he could.







GUTHRIE COUNTY SUPERVISORS HEAR UPDATES FROM ADVISORY COUNCIL ON EMS SERVICES

FEB. 15 MEETING, SHERIFF'S DEPARTMENT REVENUES QUESTIONED

On Feb. 15, the Guthrie County Board of Supervisors met for a budget work session. Supervisors discussed ways to control/ lower the tax levy rate to ease the burden on taxpayers throughout the county. The plan is to reduce it over the next four years.

Supervisor Mike Dickson shared his opinion that the county needs to do this gradually.

"If we go by the plan where we're lowering it every year for the next four years, then we should keep enough fund balance in there that we can cover everything," he said. "If we go too fast here, we could be hurting ourselves."

Regarding the upcoming fiscal year budget, Dickson questioned the projected revenues in the Sheriff's department. He said the revenue in that department through six months of the current year would not project to what is shown in the budget. The supervisors plan to visit again with department heads from which the supervisors need clarification about budgetary numbers.

FEB. 20 MEETING, OVERTIME COSTS PROBED

During the regular meeting of the Guthrie County Supervisors on Feb. 20, Supervisor Mike Dickson asked that the payroll reports approval be considered separately from the other items in the consent agenda.

"I just don't like all the overtime that's in the payroll," said Dickson. "I am going to vote 'no' on the payroll reports because I don't agree with all the overtime in there."

"One of the things I think we can do, that I would like to see ... would be for each department to have an overtime policy," said Supervisor Maggie Armstrong. "I think it would be beneficial for us, since this is part of our process now, to have an understanding as to what warrants overtime."

"There can be good reasons for it, which is fine," Dickson said. "I'd just like to know what they are if you're asking me to approve it."

The supervisors voted to approve the payroll reports, on a 3-2 vote, with Armstrong, Brian Johnson and Steve Smith voting to approve and JD Kuster and Dickson opposed.

FEB. 22 MEETING, BENEFIT OF HOUSING OUT-OF-COUNTY JAIL INMATES EXAMINED

During the Feb. 22 meeting of the Guthrie County Board of Supervisors, Conservation Director Brad Halterman addressed the supervisors about the proposed 28E agreement with the Iowa DNR regarding the Middle Raccoon River access. The supervisors approved the agreement, pending review by the county attorney.

The bulk of the meeting was a review of budgetary numbers for the upcoming fiscal year. Supervisor Mike Dickson again questioned the revenue numbers for the sheriff's department, saying the yearly number looks unrealistically large based on the current year-to-date actual revenue.

County Auditor Dani Fink agreed with the idea of budgeting revenues conservatively.

"If they bring in \$378,000, great. But it's going to hurt us if we overbudget that revenue and don't have it," Fink said.

Dickson questioned whether or not housing inmates from other counties is truly beneficial financially for the county.

"There's seven jailers, and the only reason we need seven jailers is because we're contracting with other counties to bring in inmates," Dickson said. "And if that's cost-

The consensus among the supervisors was to request more detail on the revenues and expenses.

FEB. 27 MEETING. **EMS ISSUE CONTINUES, RFPS TO BE SENT OUT**

During the Feb. 27 meeting of the Guthrie County Board of Supervisors, the supervisors heard an update on the progress of the EMS Advisory Council's efforts to find an agreement regarding the various services and municipalities that would be involved in the proposed county-wide service. County Health Director Jotham Arber shared the efforts of the council to develop a proposal.

"When we try to sell this to Guthrie County residents, we want to be sure that we put in there that this isn't just the county giving cities money," said Arber. "This is the county asking for services to be delivered and holding the service providers to account for every tax dollar ... and in exchange, Guthrie County residents are receiving quality services that are reduced in timeframe that allow our EMS professionals to save lives."

The advisory council is proposing a levy

of 75 cents per \$1,000 of taxable valuation. No formal action was taken at this time. If the supervisors decide on such a levy proposal, it will need to go to the voters to approve or reject.

The committee also suggested sending out a Request for Proposals (RFP) as the best way to get information on how the existing EMS services could cooperate to meet the service needs of the county. The supervisors chose to schedule time to dig deeper into the EMS issue at the March 5 meeting.

As part of the consent agenda, the supervisors approved a liquor license for Shootout Saloon LLC and a conservation claim for Hicklin Powersports LLC.

Regarding the existing property tax levy and the county's proposed budget for the upcoming fiscal year, the supervisors tentatively set a public hearing for Monday, April 1 at 7 p.m. That date and time were formally set during the supervisors' meeting on Feb. 29.

MARCH 5 MEETING, SOME ANSWERS ON OVERTIME

The Guthrie County Board of Supervisors met in regular session on March 5. The supervisors met with Health Director Jotham Arber to discuss details of the budgetary numbers he has proposed. The supervisors also met with Sheriff Marty Arganbright and Jesse Swensen to discuss the Sheriff's department budget.

When asked about overtime, Sheriff Arganbright pointed out that in the upcoming fiscal year, he expects overtime to be somewhat lower because the River Ruckus will not be in the county this year due to the venue being changed. He told of his ongoing efforts to control overtime.

"We try to work with using comp time, but then when you do that, you end up with people gone, and then you have to hire part-time. It's a vicious cycle," said Arganbright.

MARCH 12 MEETING, SALARY INCREASE DEBATED

During the regular meeting of the Guthrie County Board of Supervisors on March 12, the item generating the most discussion was a salary increase for the upcoming fiscal year. Supervisor Brian Johnson suggested an increase of 3.2%, saying he preferred to stay "conservative." Mike Dickson pointed out that staying conservative eventually leads to salaries no longer being competitive.

After lengthy discussion, Supervisor Steve Smith proposed a compromise.

"We could sit here for another hour and continue to beat the bush, but I'm going to throw out... to have their raises at 3.5 (percent)," he said. Johnson seconded the motion, and it passed on a three to two vote, with JD Kuster and Dickson voting nay. Kuster and Dickson stated that they felt 4% would have been feasible.

Health Director Jotham Arber addressed the supervisors with a departmental update. He spoke of recent dog bite incidents in which dogs have left their home property and bitten neighboring farmers.

"At our next Board of Health meeting, I'm going to be bringing an Animal Bite Ordinance recommendation," Arber said.

Arber explained that there are dogs that have been repeat offenders, leaving their home property and biting people on neighboring properties. He said currently, unless victims press charges, there is little the county can do. The proposed ordinance would help give the county more ability to deal with these situations.

MARCH 19 MEETING, 3.5% SALARY INCREASE FOR ELECTED OFFICIALS

The supervisors held a regular meeting on March 19. Supervisor Mike Dickson was absent. Discussion was held about the proposed salary increases for the county's elected officials.

Supervisor Brian Johnson said he suggests no salary increase for the supervisors at this time. Supervisor Steve Smith said he understands Johnson's opinion, but Smith

was concerned about creating a situation in future years, in which the supervisors may need to receive a larger increase than other Guthrie County elected officials in order stay comparable. Smith said it's best to avoid that type of "catch up" situation.

"Over time, as we are trying to encourage and recruit new people to come on the board, I think it is important that we make it advantageous enough, because the work is heavy and the work is important," Supervisor Maggie Armstrong said.

For that reason, Armstrong advocated for continuing to make incremental salary increases for the supervisors.

The supervisors voted to increase salaries for the supervisors by 3.5%, with Johnson casting the sole vote against. The supervisors unanimously voted to increase the salary of other elected officials by 3.5%. County Auditor Dani Fink discussed the Proposed Property Tax Notice Statements that will soon be sent out to taxpayers. She explained that the letters are required as part of a new process legislated by the state. Fink and the supervisors discussed that it's likely some taxpayers will have questions about the new process and the letter. The consensus was that an information form should be available so that consistent answers can be given.

The supervisors set a public hearing in relation to the proposed service level reduction on 233^{rd} Lane Section 7 Cass Township. The hearing will be Tuesday, April 2 at 9:05 a.m.

The supervisors hold regular meetings every Tuesday at 9 a.m. The public is welcome. Attendees may participate in person or by calling 323-792-6123 and inputting conference ID 547029216#.

CITY GOVERNMENT NEWS PANORA CITY COUNCIL HEARS ABOUT INSURANCE INCREASES, HOLDS FIRST READING ON WATER RATE HIKE

The Panora City Council met in regular session on Feb. 26. Chris Arganbright, representing Bryton Insurance, addressed the council about insurance changes regarding the various coverages the city maintains.

"Insurance is distressed climate in Iowa right now," Arganbright said. "Since the derecho of 2020 kicked off all kinds of wind and hail events that we've had since then, we are now in the same category as Florida and California."

She went on to explain that, because of this, wind/hail damage deductibles are rising. In general, deductibles on buildings are going to 1% of valuation, although there is the option, in some cases, of "buying down" coverage to essentially obtain a lower deductible.

The good news, according to Arganbright, is that, because the city had relatively few claims, the city is seeing a 4.5% overall increase in premiums rather than the 10% to 15% that had been expected.

The council approved Resolution 24-06, setting a public hearing on April 8 at 5:30 p.m. at Panora City Hall to hear comments regarding the proposed FY 2024-2025 property tax levy.

There was discussion about Resolution 24-07 regarding proposed pay changes for city employees. The resolution states that city employees (other than some exceptions noted) will receive a 5% pay increase effective July 1, 2024. The council approved the resolution.

The council held a first reading and discussion of proposed Ordinance 352, which would increase water service charges. The proposed ordinance would result in a monthly bill increase of \$2.80 for a typical household using 3,000 gallons of water monthly. No action was taken at this time.

The council approved a Special (five-day) Class C Alcohol License for Lucky Wife Wine Slushies T9, effective April 24-28, for the planned craft show at the Community Center to be hosted by Julie Maddox. The council also approved an annual Class C Alcohol license for outdoor services for Pedal-In.

MARCH 11 MEETING

The Panora City Council meeting on March 11 began at the city's water treatment plant. The city's water plant supervisor, Brent Christofferson, led the council in a walk-through of the water plant as he explained plant operations and maintenance. He also shared data on the plant's capacity and production numbers.

"We pumped 52 million gallons last year," Christofferson said, although he added that the plant has the capability to pump much more if needed.

Following the water plant tour, the council reconvened at city hall for the remainder of the meeting. The council approved the second reading of the water ordinance and a resolution for grant support for the grant application to put electric lines underground.

The council's next regular meeting will be Monday, March 25 at 5:30 p.m. The public is welcome. Interested persons may attend in person or electronically by visiting the website https://meet.goto.com/cityofpanora or by phone 1-312-757-3121 (Access Code 295-099-701, Audio PIN 220#). ■

Company rolls out Fiber TV+ streaming alternative

Panora Fiber held its annual business meeting on March 11 at the Panora Community Center, starting at 6 p.m. This was the formal business meeting for the two corporations, Panora Communications Cooperative and Panora Cooperative Cablevision Association, Inc. Both companies are served by the same board of directors. Ron Reynolds serves as the board president of Panora Communications Cooperative and Dave Ryan serves as the board president of Panora Cooperative Cablevision Association, Inc.

Two board members, Lynnea Andersen and LeRoy Oxley, were recommended and re-elected by the membership at the meeting. Oxley has served on the board for 12 years and Andersen for nine years.

Andrew Randol, general manager/

CEO, provided financial updates on both companies, also giving recognition to the staff, which he said provides "269 collective years of employment, which translates to 19 years per person."

Randol commented how the managed wi-fi continues to grow and that texting services will be added for those who prefer paperless billings and electronic appointment notices.

Randol also noted how the number of cable TV subscribers continues to decline, dropping from 572 in 2022 to 510 in 2023. He said the subscriber count was more than 1,500 at its peak. He also shared how programming costs continue to increase, now accounting for 80 cents of every dollar. Randol shared how the company will be replacing its traditional cable TV offerings with a new streaming program called Panora Fiber TV+.

Curtis Thornberry, technology development director, provided a demonstration on how the Panora Fiber TV+ application works and addressed questions from those in attendance. He explained


